What is this product?

Type The product is a Fund structured as an open-ended investment company with variable capital, organised under the laws of Ireland as a public limited company and regulated as a UCITS.

Term There is no fixed maturity date for the Fund and the Fund has no automatic termination. You may sell your shares without penalty on each day when banks in Ireland are open for normal business and the New York Stock Exchange is open for trading. All of the Shares in a Fund or Class may be redeemed by the manufacturer with notice to shareholders under the circumstances described in the Fund Prospectus under the heading "Termination".

Objectives The Fund seeks a high rate of total return consistent with longterm preservation of capital. The Fund invests in a diversified portfolio of bonds and other debt instruments of issuers from at least three different countries, including emerging market countries. The Fund is not required to allocate its investments in set percentages to particular countries and may invest in emerging markets without limit. Under normal circumstances, the Fund invests at least 40% of its net asset value in securities of non-U.S. issuers and invests at least 80% of its net asset value in debt instruments, which may, in each case, be represented by derivatives such as forwards, futures contracts, swap agreements, or options.

Debt instruments in which the Fund may invest include, but are not limited to, government and government-related obligations, mortgage- and assetbacked securities, corporate and municipal bonds, collateralised mortgage obligations, repurchase agreements, and other debt securities, and may include fixed and floating rate instruments. The Fund invests in both U.S. dollar-denominated and non-U.S. currency denominated debt instruments. The Fund invests primarily in high quality debt instruments, but may also invest up to 25% of its net asset value in lower rated debt instruments, commonly referred to as high yield or "junk" bonds. In selecting investments, Dodge & Cox considers many factors, including yield-tomaturity, quality, liquidity, call risk, current yield, and potential for capital and currency appreciation. The Fund will invest in an array of securities with short, intermediate, and long maturities in varying proportions. The Fund may use derivatives to manage risk and help meet the Fund's objective. A derivative is a financial instrument whose value is based on the performance of another financial asset, index, or investment. The Fund may invest in other types of eligible investments which are disclosed in the Fund's Prospectus.

The Fund is actively managed and uses the Bloomberg Global Aggregate Bond Index benchmark for performance comparison purposes only. The Fund's portfolio of investments is built through a process of individual security selection, and Dodge & Cox is not constrained by the benchmark in the selection of investments for the Fund. The Fund's investment strategy does not restrict the extent to which the Fund's portfolio may deviate from the benchmark.

Intended retail investor Investment in the Fund may be appropriate for investors with a long-term investment horizon who are seeking long-term capital appreciation. The Fund is not appropriate for short-term investors or those seeking income. The investor should be prepared to bear losses.
