What is this product?

Type The product is a Fund structured as an open-ended investment company with variable capital, organised under the laws of Ireland as a public limited company and regulated as a UCITS.

Term There is no fixed maturity date for the Fund and the Fund has no automatic termination. You may sell your shares without penalty on each day when banks in Ireland are open for normal business and the New York Stock Exchange is open for trading. All of the Shares in a Fund or Class may be redeemed by the manufacturer with notice to shareholders under the circumstances described in the Fund Prospectus under the heading "Termination".

Objectives The Fund seeks long-term growth of principal and income. The Fund invests primarily in a diversified portfolio of emerging markets equity securities issued by companies from at least three different countries. The Fund is not required to allocate its investments in set percentages in particular countries. Under normal circumstances, the Fund will invest at least 80% of its Net Asset Value in equity securities of emerging market issuers. Equity securities may include common stocks, depositary receipts evidencing ownership of common stocks, preferred stocks and securities convertible into common stocks, and securities that carry the right to buy common stocks (e.g., rights and warrants). Derivative transactions that have economic characteristics similar to such equity securities are included in the Fund's 80% investment policy.

In selecting investments, the Fund invests primarily in companies that, in Dodge & Cox's opinion, appear to be temporarily undervalued by the stock market but have a favourable outlook for long-term growth. Dodge & Cox relies on Fundamental research to select investments for the Fund's portfolio, supplemented by financial models that help identify companies from within the Fund's investment universe for further consideration by research analysts. The Fund also focuses on the underlying financial condition and prospects of individual companies, including future earnings, cash flow, and dividends. Various other factors, including financial strength, economic condition, competitive advantage, quality of the business

franchise, and the reputation, experience, and competence of a company's management are weighed against valuation in selecting individual securities. The Fund also considers the economic and political stability of a country and the protections provided to shareholders. The Fund may use derivatives to manage risk and help meet the Fund's objective. A derivative is a financial instrument whose value is based on the performance of another financial asset, index, or investment. The Fund may invest in other types of eligible investments which are disclosed in the Fund's Prospectus.

The Fund is actively managed and uses the MSCI Emerging Markets Index benchmark for performance comparison purposes only. The Fund's portfolio of investments is built through a process of individual security selection, and Dodge & Cox is not constrained by the benchmark in the selection of investments for the Fund. The Fund's investment strategy does not restrict the extent to which the Fund's portfolio may deviate from the benchmark.

Intended retail investor Investment in the Fund may be appropriate for investors with a long-term investment horizon who are seeking long-term capital appreciation. The Fund is not appropriate for short-term investors or those seeking income. The investor should be prepared to bear losses.

Further Information The base currency of the Fund is U.S. dollars, and the shares described in this document are denominated in EUR. Dividend income will be reinvested in the Fund and will not be distributed to you. The Fund's Depositary is State Street Custodial Services (Ireland) Limited. What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for a minimum of 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 5 out of 7, which is a medium-high risk class. The Fund invests mainly in equity and equity-related securities of companies, which have historically been subject to significant price movements that may occur suddenly due to market or company-specific factors.

Other material risks relevant to the product not included in the summary risk indicator are set out in the Fund Prospectus. This product does not include any protection from future market performance, so you could lose some or all of your investment.
