You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type: Shares in Macquarie Euro Government Bond Fund (the "Sub-Fund"), being a compartment of Macquarie Fund Solutions, a Luxembourg incorporated investment company with variable capital qualifying as Undertaking for Collective Investment in Transferable Securities (UCITS).

Term: The share of the Sub-Fund is issued in registered form. The Sub-Fund does not have a fixed maturity date and is established for an unlimited duration though it may also be dissolved by compulsory redemption upon a decision of the Directors (i) if its Net Asset Value has decreased below the minimum holding deemed appropriate for its existence in the interest of the Shareholders, or (ii) if a change in its economical or political situation would have material adverse consequences for its investments, or (iii) in order to proceed to an economic rationalization.

Objective: To provide robust ongoing performance while at the same time giving due consideration to the liquidity of the underlying assets.

Portfolio Securities: Under normal conditions, the Sub-Fund seeks exposure mainly to European credit-based securities issued by governments or other governmental entities. The Sub-Fund covers the entire maturity spectrum and may also have exposure to other credit-based securities, money market instruments and cash. The Sub-Fund may use financial instruments to manage its exposure to various investment risks (hedging) and to seek investment gains.

Investment Process: The investment manager is actively managing the Sub-Fund and is not constrained by any benchmark. The investment manager takes active allocation decisions and also makes

use of a duration overlay. The Sub-Fund promotes environmental and/ or social characteristics, as further described in the Prospectus.

Income earned by the Sub-Fund is accumulated in the net asset value of this class and not distributed.

Intended retail investor: This Sub-Fund may not be appropriate for investors who plan to withdraw their money within 3 to 5 years. This product is for retail investors with basic investment knowledge, seeking robust ongoing performance and liquidity through an actively managed fund invested in European government bonds. Investors should be looking to invest for at least three to five years and should appreciate that their capital will be at risk and that the value of their investment and any derived income may fall as well as rise. Particular performance risks include rising market interest rates, decreasing creditworthiness of bond issuers and unusual market conditions.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

A shorter holding period can cause a loss due to short-term variations in the value of securities and exchange rates.

You can place orders to buy or sell Sub-Fund shares at any time. Orders received on any given Luxembourg business day before 12 p.m. Luxembourg time will be processed at that day's share price.

When selling early, you will not incur any fees or penalties that are related to disinvestments within the recommended holding period. Please refer to the exit costs described in the section "What are the costs?".
