You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type: Shares in Macquarie Supranational Emerging Markets LC Bond Fund (the "Sub-Fund"), being a compartment of Macquarie Fund Solutions, a Luxembourg incorporated investment company with variable capital qualifying as Undertaking for Collective Investment in Transferable Securities (UCITS).

Term: The share of the Sub-Fund is issued in registered form. The Sub-Fund does not have a fixed maturity date and is established for an unlimited duration though it may also be dissolved by compulsory redemption upon a decision of the Directors (i) if its Net Asset Value has decreased below the minimum holding deemed appropriate for its existence in the interest of the Shareholders, or (ii) if a change in its economical or political situation would have material adverse consequences for its investments, or (iii) in order to proceed to an economic rationalization.

Objective: To provide investors with current income and the potential for medium to long term capital appreciation.

Portfolio Securities: Under normal conditions, the Sub-Fund primarily invests in bonds and/or securitised debt instruments that are issued or guaranteed by supranational agencies. These instruments are primarily denominated in local currencies from emerging countries. To a lesser extent, the Sub-Fund may also invest in other bonds and/or other securitised debt instruments, money market instruments and cash when the investment manager expects returns from those securities to contribute to meeting the investment objective of the Sub-Fund and/or to enhance liquidity. At least 50% of the Sub-Fund's investment will be sustainable investments. The Sub-Fund may invest up to 10% of its net assets in Chinese bonds through the China Bond Connect. The Sub-Fund may use financial instruments to manage its exposure to various investment risks (hedging) and to seek investment gains.

Investment Process: The investment manager is actively managing the Sub-Fund and is not constrained by any benchmark. The Sub-Fund promotes environmental, and/or social characteristics, as further described in the prospectus.

Benchmark: JPM Government Bond Index-Emerging Markets Global Diversified. The benchmark is a performance reference and the Sub-Fund's underlying portfolio may differ significantly to the benchmark composition.

Income earned by the Sub-Fund is accumulated in the net asset value of this class and not distributed.

Intended retail investor: This Sub-Fund may not be suitable for investors that want to withdraw their money within 5 years. This product is for professional investors with good investment knowledge, seeking medium- to long-term capital appreciation through an actively managed fund invested in bonds and/or securitised debt instruments that are issued or guaranteed by supranational agencies. Investors should be looking to invest for at least five years and should appreciate that their capital will be at risk and that the value of their investment and any derived income may fall as well as rise. Particular performance risks include rising market interest rates and falling exchange rates in emerging markets currencies.

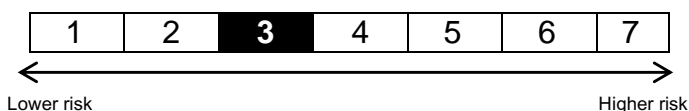

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 5 years.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the Sub-Fund's capacity to pay you.

The investor of this Product will not face financial loss due to the default of the investment manager, the Management Company, as the Sub-Fund is considered to be a separate entity with segregated assets.

The SICAV is not part of any investment compensation or guarantee scheme.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

A shorter holding period can cause a loss due to short-term variations in the value of securities and exchange rates.

You can place orders to buy or sell Sub-Fund shares at any time. Orders received on any given Luxembourg business day before 12 p.m. Luxembourg time will be processed at that day's share price.

When selling early, you will not incur any fees or penalties that are related to disinvestments within the recommended holding period. Please refer to the exit costs described in the section "What are the costs?".
