You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type: Shares in Macquarie Emerging Markets Debt Select Opportunities Fund (the "Sub-Fund"), being a compartment of Macquarie Fund Solutions, a Luxembourg incorporated investment company with variable capital qualifying as Undertaking for Collective Investment in Transferable Securities (UCITS).

Term: The share of the Sub-Fund is issued in registered form. The Sub-Fund does not have a fixed maturity date and is established for an unlimited duration though it may also be dissolved by compulsory redemption upon a decision of the Directors (i) if its Net Asset Value has decreased below the minimum holding deemed appropriate for its existence in the interest of the Shareholders, or (ii) if a change in its economical or political situation would have material adverse consequences for its investments, or (iii) in order to proceed to an economic rationalization.

Objective: To provide investors with an excess return over cash through the cycle.

Portfolio Securities: Under normal conditions, the Sub-Fund primarily invests in emerging markets bonds and their derivatives, such as currency forward and options and Futures. The Sub-Fund may invest up to 10% of its assets in Chinese bonds through the China Bond Connect. The Sub-Fund may invest up to 10% of its net assets in contingent convertible bonds. The Sub-Fund may not invest more than 25% of its net assets in a single emerging country. On an ancillary basis the Sub-Fund may hold cash and cash equivalents and if justified by exceptional market conditions, up to 100% of its net assets. The Sub-Fund may use financial instruments to manage its exposure to various investment risks (hedging) and to seek investment gains.

Investment Process: The investment manager is actively managing the Sub-Fund and has all discretion with respect to the composition of the portfolio. The investment manager will seek to invest in a diversified portfolio of emerging markets debt using a flexible approach that adapts to the prevailing market environment. The Sub-Fund promotes environmental and/or social characteristics, as further described in the Prospectus. **Benchmark**: ICE BofAML 0-3 Month Treasury Bill Index for USD denominated shares and ICE German T-Bill 0-3 month for EUR denominated shares. The benchmark is a performance reference and the Sub-Fund's underlying portfolio may differ significantly to the benchmark composition.

Any income earned is declared monthly. You may elect to either receive such income in cash or reinvested in the Sub-Fund.

Intended retail investor: This Sub-Fund may not be appropriate for investors who plan to withdraw their money within 3 years. This product is for retail investors with basic investment knowledge, seeking an excess return over cash through the business cycle through an actively managed fund invested in emerging markets bonds. Investors should be looking to invest for at least three years and should appreciate that their capital will be at risk and that the value of their investment and any derived income may fall as well as rise. Particular performance risks include potential adverse political, economic or social developments and falling exchange rates in emerging markets currencies.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

- EUR 10000 is invested.

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be -1.5% before costs and -4.8% after costs.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the Sub-Fund's capacity to pay you.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

A shorter holding period can cause a loss due to short-term variations in the value of securities and exchange rates.

You can place orders to buy or sell Sub-Fund shares at any time. Orders received on any given Luxembourg business day before 6 p.m. Luxembourg time will be processed at that day's share price.

When selling early, you will not incur any fees or penalties that are related to disinvestments within the recommended holding period. Please refer to the exit costs described in the section "What are the costs?".
