You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type: Shares in Macquarie US Large Cap Core Equity Fund (the "Sub-Fund"), being a compartment of Macquarie Fund Solutions, a Luxembourg incorporated investment company with variable capital qualifying as Undertaking for Collective Investment in Transferable Securities (UCITS).

Term: The share of the Sub-Fund is issued in registered form. The Sub-Fund does not have a fixed maturity date and is established for an unlimited duration though it may also be dissolved by compulsory redemption upon a decision of the Directors (i) if its Net Asset Value has decreased below the minimum holding deemed appropriate for its existence in the interest of the Shareholders, or (ii) if a change in its economical or political situation would have material adverse consequences for its investments, or (iii) in order to proceed to an economic rationalization.

Objective: The Sub-Fund aims to provide Shareholders with capital growth and appreciation by investing in common stocks of large-capitalization companies.

Portfolio Securities: The Sub-Fund will aim to meet the investment objective under normal circumstances by investing primarily at least 80% of its net assets in equity securities, primarily in common stocks of large-capitalization companies.

The securities will principally be listed, traded, or dealt in on a Regulated Market in the US, although up to 10% of the net assets of the Sub-Fund may be invested in the securities of non-US issuers at any one time whose securities will be listed, traded, or dealt in on any Regulated Market in a member state of the OECD.

The Sub-Fund may invest up to 20% of its net assets in non-US companies directly, or indirectly through ADRs, GDRs, or EDRs.

Money market instruments, money market funds, bank deposits and time deposits qualifying as eligible asset may be held where this is considered appropriate by the Investment Manager. The Sub-Fund may hold ancillary liquid assets for not more than 20% of its total assets.

Investment Process: The Sub-Fund shall invest in companies that the Investment Manager believes are high-quality, have sustainable competitive advantages accompanied by financial strength and earnings stability, and have leading positions in their industries. Large-capitalization companies typically are companies with market capitalizations of at least \$10 billion at the time of acquisition. The Sub-Fund shall invest in securities that have the potential for capital appreciation, or that the Investment Manager expects to resist market decline. Although the Sub-Fund primarily invests in securities issued by large-capitalization companies, it may invest in securities issued by companies of any size. The Sub-Fund may invest in securities of companies across the valuation spectrum, including securities issued by growth and value companies. Considering that long-term earnings potential relative to market expectations is an important component for stock performance, the Investment Manager balances a top-down (assessing the market environment) approach with a bottom-up (researching individual issuers) analysis when selecting securities for the Sub-Fund, and seeks to exploit what it believes to be catalysts for multi-year earnings growth in companies that it believes have strong or strengthening competitive advantages. Earnings catalysts are diversified across both thematic and company-specific projections.

Benchmark: S&P 500 Net Return Index. The benchmark is a performance reference and the Sub-Fund's underlying portfolio may differ significantly to the benchmark composition.

Any income earned is declared yearly. You may elect to either receive such income in cash or reinvested in the Sub-Fund.

Intended retail investor: This Sub-Fund may not be appropriate for investors who plan to withdraw their money within 3 years. This product is for retail investors with basic investment knowledge, seeking an excess return over cash through the business cycle through an actively managed fund invested in emerging markets bonds. Investors should be looking to invest for at least three years and should appreciate that their capital will be at risk and that the value of their investment and any derived income may fall as well as rise. Particular performance risks include potential adverse political, economic or social developments and falling exchange rates in emerging markets currencies.

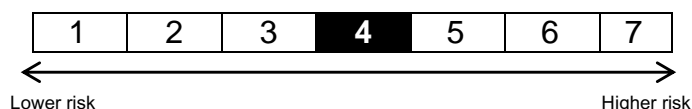

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 5 years.

Costs over Time

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

A shorter holding period can cause a loss due to short-term variations in the value of securities and exchange rates.

You can place orders to buy or sell Sub-Fund shares at any time. Orders received on any given Luxembourg business day before 12 p.m. Luxembourg time will be processed at that day's share price.

When selling early, you will not incur any fees or penalties that are related to disinvestments within the recommended holding period. Please refer to the exit costs described in the section "What are the costs?".
