Objectives and investment policy

Objective: To provide investors with long-term capital appreciation by investing in equity and equity related securities of US issuers (mainly large cap).

Portfolio Securities: Under normal circumstances, Macquarie US Large Cap Value Fund (the "Sub-Fund") invests at least 80% of its net assets in a well-diversified portfolio of US equity and equity-related securities of large sized issuers that, at the time of investment, have a market capitalisation within the range of market capitalisation of companies in the Russell 1000® Value Index, which the Investment Manager believes have long-term capital appreciation potential. The Sub-Fund may invest in financial derivative instruments for efficient portfolio management. The Sub-Fund may be leveraged up to 30% of its net asset value as a result of its use of derivative instruments.

Investment Process: The Investment Manager is actively managing the Sub-Fund and is not constrained by any benchmark. Investments are selected following analysis and research to identify investments that are undervalued or have fávourable earnings prospectus and dividend


Designed for: This Sub-Fund may not be appropriate for investors who plan to withdraw their money within 5 to 7 years.

The Sub-Fund primarily invests in equity securities of large US companies which appear to be undervalued by the market and which may experience moderate rises and falls in value.

If your currency as an investor is different from the reference currency of the Sub-Fund, changes in currency exchange rates could reduce any investment gains or increase any investment losses.

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks. The Sub-Fund is subject to the following risks which may not be adequately captured by the indicator:

- Because the Sub-Fund expects to hold a concentrated portfolio of a limited number of securities, the Sub-Fund's risk may be increased because each investment has a greater effect on the Sub-Fund's overall performance.
- The Sub-Fund maintains a diversified portfolio representing a number of different industries, which helps to minimise the impact that any one industry could have on the portfolio.
- Certain derivatives could increase the Sub-Fund's volatility or expose the Sub-Fund to losses greater than the cost of the derivatives.
- Certain securities could become hard to value, or to sell at a desired time and price.


