## What is this product?

### Type

This is a Sub-Fund (the "Sub-Fund") of onemarkets Fund. onemarkets Fund is an investment company with variable share capital (SICAV) with multiple Sub-Funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.

### Term

The Sub-Fund is established for an unlimited duration. The Management Company can proceed unilaterally to a redemption of a share class of an investor or switch the holding to another share class if the investor no longer meets the qualifying criteria to maintain the share class he holds. The Board of Directors may decide under certain circumstances to compulsorily redeem all shares of the relevant Sub-Fund or share class at the Net Asset Value per share for the valuation date in respect of which such decision shall be effective, and to terminate and liquidate such Sub-Fund or share class.

### Objectives

**Investment Objective:** The Sub-Fund's investment objective is to provide long-term capital growth by investing primarily in emerging market companies. The primary objective is to harvest portfolio manager alpha across a diverse range of strategies with proven track records.

**Investment Strategy:** The Sub-Fund will seek to achieve its investment objective by using a proprietary multi-factor model to quantitatively rank countries, which supports the Sub-Fund's portfolio construction. The Investment Manager selects individual securities after performing a risk/reward analysis, and research into individual securities conducted by research analysts, to address the Sub-Fund's objective of providing a high total return. The Sub-Fund promotes a broad range of environmental and social characteristics through its inclusion criteria for investments that promote environmental and/or social characteristics, as well as certain norms and values by excluding particular companies from the portfolio. Furthermore, the Sub-Fund does consider Principal Adverse Impact Indicators (PAIs) on sustainability factors in accordance with article Art. 7(1) of the Sustainable Finance Disclosure Regulation (SFDR).

**Investment Policy:** The Sub-Fund invests at least 80% of its assets in equity securities and equity-related instruments that are tied economically to emerging markets. Emerging markets include most countries in the world except Australia, Canada, Japan, New Zealand, the United Kingdom, the United States, most of the countries of Western Europe and Hong Kong. The Sub-Fund may invest in companies across all market capitalizations, although the Sub-Fund may invest a significant portion of its assets in companies of any one particular market capitalization category. Equity securities and equity-related instruments tied economically to an emerging market include:

- (i) securities of issuers that are organised under the laws of an emerging market country or that maintain their principal place of business in an emerging market country;
- (ii) securities that are traded principally in an emerging market country;
- (iii) securities of issuers that, during their most recent fiscal year, derived at least 50% of their revenues or profits from goods produced or sold, investments made,

or services performed in an emerging market country or that have at least 50% of their assets in an emerging market country;

- (iv) securities or other instruments that expose the Sub-Fund to the economic fortunes and risks of one or more emerging market countries.

There is no limit on the number of countries in which the Sub-Fund may invest, and the Sub-Fund may focus its investments in a single country or a small group of countries. The Sub-Fund may use exchange-traded funds to gain exposure to particular foreign securities or markets and for the efficient management of cash flows. The Sub-Fund may invest in securities denominated in any currency and will invest substantially in securities denominated in foreign currencies. The Sub-Fund's benchmark is the MSCI Emerging Markets Index. The majority of the Sub-Fund's equity securities may not necessarily be components of or have weightings derived from the Index. The Investment Manager has a wide range of discretion relative to the Index. The Sub-Fund may invest in financial derivative instruments but will not invest in contingent convertible bonds ("CoCos"). **Derivatives:** The Sub-Fund may use financial derivatives for hedging purposes and to achieve investment objective.

**Securities Financing Transactions:** The Sub-Fund will not enter into transactions under SFTR.

**Techniques and Instruments:** The Sub-Fund will not use Efficient Portfolio Management Techniques. For more information, please refer to the prospectus.

**Benchmark and use:** The Sub-Fund does not use any index under the Benchmark Regulation.

**SFDR classification:** The Sub-Fund qualifies as a financial product under Art. 8 of SFDR.

**Distribution policy:** This is an accumulating share class.

**Subscription and Redemption:** Shares are issued on each Valuation Day at the issue price. Shareholders are entitled to request the redemption of their Shares at any time at the Net Asset Value per share.

**Currency:** The reference currency of the Sub-Fund is the EUR.

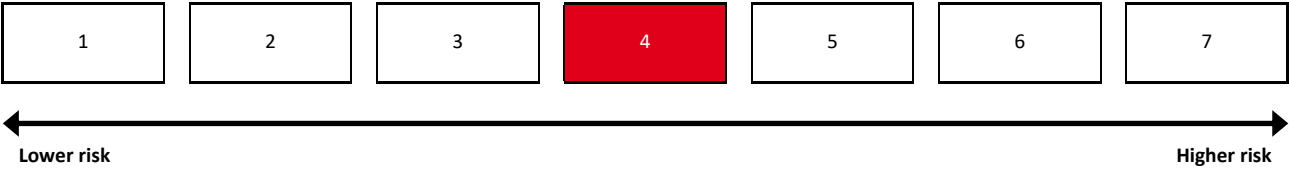

### Intended Retail Investor

This share class is open for retail investors. An investment in this Sub-Fund is suitable only for investors who are able to appraise the risks and economic value of the investment. The investor must be prepared to accept a significant volatility of the Sub-Fund and potentially high capital losses in order to achieve high potential investment performances. The Sub-Fund is intended for investors with a long-term investment horizon.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 4 years. The actual risk can vary significantly if you cash in at an early stage and you might get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.  
We have classified this Product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity to pay you.  
This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

What happens if Structured Invest S.A. is unable to pay out?

The assets of the Sub-Fund are held in safekeeping by its depositary, CACEIS Bank, Luxembourg Branch (the “Depositary”). In the event of the insolvency of the management company, the Sub-Fund’s assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary’s insolvency, or someone acting on its behalf, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations). The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

What are the costs?

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time. There is no arranged compensation or guarantee scheme for investors in the Sub-Fund.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:  
- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.  
- EUR 10 000 is invested.

#### Recommended holding period: 4 years
