What is this product?

Type

This is a Sub-Fund (the "Sub-Fund") of onemarkets Fund. onemarkets Fund is an investment company with variable share capital (SICAV) with multiple Sub-Funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.

Term

The Sub-Fund is established for an unlimited duration. The Management Company can proceed unilaterally to a redemption of a share class of an investor or switch the holding to another share class if the investor no longer meets the qualifying criteria to maintain the share class he holds. The Board of Directors may decide under certain circumstances to compulsorily redeem all shares of the relevant Sub-Fund or share class at the Net Asset Value per share for the valuation date in respect of which such decision shall be effective, and to terminate and liquidate such Sub-Fund or share class.

Objectives

Investment Objective: The Sub-Fund's investment objective is primarily to generate income and, secondarily, increase the value of the investor's investment over the recommended holding period.

Investment Strategy: The Sub-fund promotes environmental and/or social characteristics by complying with the ESG analysis framework and scoring methodology of the Investment Manager which includes a mix of exclusion, ESG integration and engagement approach. The Investment Manager uses its own global economic analysis to determine the most attractive asset types and geographical regions. Two fields are assessed for Environment, Social, and Governance (ESG).

- exposure to ESG risks and opportunities, including sustainability factors and sustainability risks, and

- how corporates manage these challenges in each of their sectors. As far as issuers of listed securities are concerned.

The Sub-Fund does consider Principal Adverse Impact Indicators (PAIs) on sustainability factors in accordance with article Art. 7(1) of the Sustainable Finance Disclosure Regulation (SFDR) Regulation (EU) 2019/2088.

Investment Policy: The Sub-Fund will mainly invest in a broad range of securities from around the world, including emerging markets which may include:

Up to 50% of its net assets in equities, government and corporate bonds and Money Market instruments. Investments in bonds with a rating below investment grade will not exceed 60% of the Sub-Fund's net assets, and those in unrated bonds will not exceed 5% of the Sub-Fund's net assets. The Sub-Fund may invest up to 50% of its net assets, in securities that are denominated in currencies other than the Euro. The Sub-Fund's bond investments may be of any quality (investment grade or below). Investments in bonds with a rating below investment grade will not exceed 60% of the Sub-Fund's net assets whilst investments in unrated bonds will only represent a very limited portion of the Sub-Fund's portfolio (not exceeding

5% of the Sub-Fund's net assets). The Sub-Fund may also hold investments up to 30% of its net assets, whose values are linked to prices of "real assets" such as, but not limited to real estate, infrastructure and commodities, through UCITS eligible investments. The Sub-Fund may invest up to 10% in convertible bonds and contingent convertible bonds, depositary receipts and other UCITS. In case of investment in units of UCITS or UCITS-ETFs, potential retrocessions will benefit to the Sub-Fund. The Sub-Fund may also invest in ancillary basis up to 20%. For more information, please refer to the prospectus. A minimum of 75% of the Sub-Fund's securities and instruments will be used to meet the promoted environmental or social characteristics. Furthermore, the sub-fund commits to have a minimum of 5% of Sustainable Investments according to article 2(17) SFDR which are part of the 75% mentioned above.

Derivatives: the Sub-Fund may invest in financial derivative instruments eligible under the 2010 Law.

Securities Financing Transactions: The Sub-Fund will enter into transactions under SFTR.

Techniques and Instruments: The Sub-Fund may use Efficient Portfolio Management Techniques. For more information, please refer to the prospectus.

Benchmark and use: The Sub-Fund does not use any index under the Benchmark Regulation.

SFDR classification: The Sub-Fund qualifies as a financial product under Art. 8 of SFDR.

Distribution policy: This is an accumulating share class.

Subscription and Redemption: Shares are issued on each Valuation Day at the issue price. Shareholders are entitled to request the redemption of their Shares at any time at the Net Asset Value per share.

Currency: The reference currency of the Sub-Fund is the EUR.

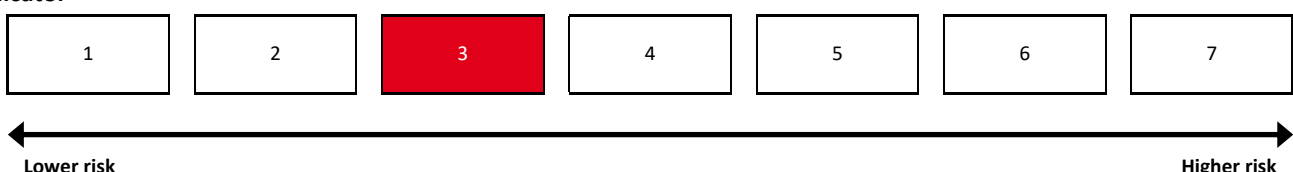

Intended Retail Investor

This share class is open for retail investors. An investment in this Sub-Fund is suitable only for investors who are able to appraise the risks and economic value of the investment. The investor must be prepared to accept a medium volatility of the Sub-Fund and potentially capital losses in order to achieve moderate potential investment performances. The sub-fund is intended for investors with a medium-term investment horizon.

What are the risks and what could I get in return?

Risk Indicator





The risk indicator assumes you keep the product for 4 years. The actual risk can vary significantly if you cash in at an early stage and you might get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

What happens if Structured Invest S.A. is unable to pay out?

The assets of the Sub-Fund are held in safekeeping by its depositary, CACEIS Bank, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the management company, the Sub-Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations). The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

What are the costs?

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time. There is no arranged compensation or guarantee scheme for investors in the Sub-Fund.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 4 years

The recommended holding period is based on our assessment of the risk and reward characteristics and costs of the product. Possible share class specific redemption fees have to be taken into account for disinvestments. You can redeem your investment at any time as set out in the prospectus. You may receive less than expected if you cash in earlier than the RHP since the Fund will be less likely to achieve its objectives.
