What is this product?

Type

This is a Sub-Fund (the "Sub-Fund") of onemarkets Fund. onemarkets Fund is an investment company with variable share capital (SICAV) with multiple Sub-Funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.

Term

The Sub-Fund is established for an unlimited duration. The Management Company can proceed unilaterally to a redemption of a share class of an investor or switch the holding to another share class if the investor no longer meets the qualifying criteria to maintain the share class he holds. The Board of Directors may decide under certain circumstances to compulsorily redeem all shares of the relevant Sub-Fund or share class at the Net Asset Value per share for the valuation date in respect of which such decision shall be effective, and to terminate and liquidate such Sub-Fund or share class.

Objectives

Investment Objective: The Sub-Fund's investment objective is to maximize total return, consistent with preservation of capital.

Investment Strategy: The Investment Manager will have full discretion within the investment policy to invest in Fixed Income Instruments and related securities. "Fixed Income Instruments" include bonds, debt securities and other similar instruments issued by various public or private sector entities. The Sub-Fund is a global fixed income portfolio, which will actively invest primarily in investment grade fixed income instruments denominated in major world currencies across a broad range of fixed income sectors including (but not limited to) government, government related and corporate bonds with short-medium term maturity profile. Exposures will be obtained via plain vanilla securities, as well as derivatives. The Investment Manager selects the Sub-Fund's foreign country and currency compositions based on an evaluation of various factors, including, but not limited to, relative interest rates, exchange rates, monetary and fiscal policies, trade and current account balances. The average portfolio duration of the Sub-Fund normally varies between 0 and 5 years.

Investment Policy: The Sub-Fund primarily invests in investment grade debt securities. It may invest up to 20% of its net assets in high yield securities ("junk bonds"), as rated by the credit rating agencies Moody's Investors Service, Standard and Poor's Rating Services or Fitch, or, if unrated, as determined following the Investment Manager's assessment. The Sub-Fund will normally limit its investments in securities and instruments that are economically tied to emerging market countries, including China Onshore market to 20% of its net assets. The Sub-Fund may invest without limitation in instruments denominated in currencies other than the Sub-Fund's reference currency, but will normally limit its foreign currency exposure to 20% of its net assets. No more than 10% of the Sub-Fund's net assets will be invested in shares or units of UCITS of UCITS exchange traded funds. Potential retrocessions will be for benefit of the Sub-Fund. The Sub-Fund may use

derivative instruments for investment or hedging purpose. Exposure to Asset-Backed securities and Mortgage-Backed Securities and other securitised assets is limited to 10% of its net assets. All securitised assets shall be eligible investments under the 2010 law. The Sub-Fund may also invest on ancillary basis up to 20%. For more information, please refer to the prospectus.

Derivatives: The Sub-Fund may use financial derivatives for hedging purposes and for investment purposes or efficient portfolio management.

Securities Financing Transactions: The Sub-Fund will enter into transactions under SFTR.

Techniques and Instruments: The Sub-Fund may use Efficient Portfolio Management Techniques. For more information, please refer to the prospectus.

Benchmark and use: The Sub-Fund does not use any index under the Benchmark Regulation. The Sub-Fund intends to measure its performance against the Bloomberg Global Aggregate 1-3 years EUR hedged (the "Benchmark"). The Sub-Fund is considered to be actively managed in reference to the Benchmark by virtue of the fact that it uses the Benchmark for performance comparison purposes. However, the Benchmark is not used to track the return of the Benchmark, to define the asset allocation of the Sub-Fund's portfolio or to compute performance fees.

SFDR classification: The Sub-Fund qualifies as a financial product under Art. 6 of SFDR.

Distribution policy: This is an accumulating share class.

Subscription and Redemption: Shares are issued on each Valuation Day at the issue price. Shareholders are entitled to request the redemption of their Shares at any time at the Net Asset Value per share.

Currency: The reference currency of the Sub-Fund is the EUR.

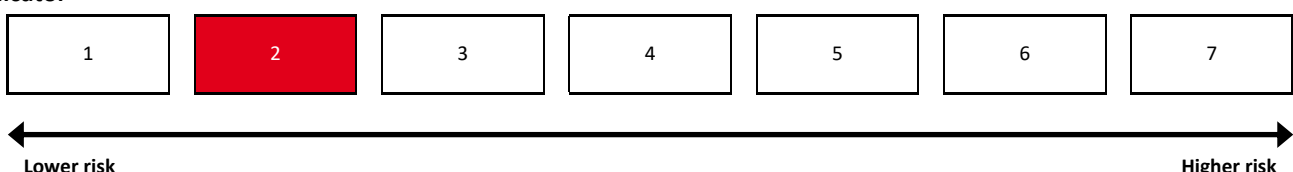

Assets and liabilities of each Sub-Fund of onemarkets Fund SICAV are segregated, meaning that your investment in this Sub-Fund is only impacted by profits and losses in this Sub-Fund. Intended Retail Investor

This share class is open for financial intermediaries which do not accept and retain inducements including intermediaries providing discretionary portfolio management. An investment in this Sub-Fund is suitable only for investors who are able to appraise the risks and economic value of the investment. The investor must be prepared to accept a low volatility of the Sub-Fund and potentially capital losses in order to achieve returns slightly higher than the usual market's interest level. The Sub-Fund is intended for investors with a short-term investment horizon.

What are the risks and what could I get in return?

Risk Indicator





The risk indicator assumes you keep the product for 2 years. The actual risk can vary significantly if you cash in at an early stage and you might get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. Unfavourable scenario: This type of scenario occurred for an investment using a suitable benchmark between December 2020 and December 2022.

Favourable scenario: This type of scenario occurred for an investment using a suitable benchmark between October 2023 and October 2025.

What happens if Structured Invest S.A. is unable to pay out?

The assets of the Sub-Fund are held in safekeeping by its depositary, CACEIS Bank, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the management company, the Sub-Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations). The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

What are the costs?

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time. There is no arranged compensation or guarantee scheme for investors in the Sub-Fund.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 2 years

The recommended holding period is based on our assessment of the risk and reward characteristics and costs of the product. Possible share class specific redemption fees have to be taken into account for disinvestments. You can redeem your investment at any time as set out in the prospectus. You may receive less than expected if you cash in earlier than the RHP since the Fund will be less likely to achieve its objectives. The RHP must not be taken as a guarantee or an indication of future performance, return or risk levels.
