What is this product?

Type

This is a Sub-Fund (the "Sub-Fund") of onemarkets Fund. onemarkets Fund is an investment company with variable share capital (SICAV) with multiple Sub-Funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.

Term

The Sub-Fund is established for an unlimited duration. The Management Company can proceed unilaterally to a redemption of a share class of an investor or switch the holding to another share class if the investor no longer meets the qualifying criteria to maintain the share class he holds. The Board of Directors may decide under certain circumstances to compulsorily redeem all shares of the relevant Sub-Fund or share class at the Net Asset Value per share for the valuation date in respect of which such decision shall be effective, and to terminate and liquidate such Sub-Fund or share class.

Objectives

Investment Objective: The Sub-Fund's investment objective is to deliver a positive total return over the medium-term. The Sub-Fund invests at least 80% of its total assets in fixed income securities.

Investment Strategy: The Sub-Fund is seeking a positive total return over the medium-term. The Sub-Fund invests at least 80% of its net assets in fixed income transferable securities, denominated in various currencies, issued by governments, quasi-sovereigns, agencies, and corporates. The Sub-Fund will focus on Euro denominated bonds but will retain flexibility to invest in non-Euro denominated bonds.

Investment Policy: The Sub-Fund may invest in but is not limited to government bonds, government-related bonds, corporate bonds, covered bonds, municipal bonds, Money Market Instruments, collective investment schemes eligible under article 41(1)e) of the 2010 Law. Up to 100% of the Sub-Fund's net assets can be invested in bonds and Money Market Instruments issued or guaranteed by France, Germany, Belgium, Austria and The Netherlands. It may also invest in the following instruments:

- hybrid Securities from investment grade rated issuers: minimum BB- rating,
- subordinated bonds including hybrids: maximum 15% of the Sub-Fund's net assets,
- financial issuers: maximum 60% of the Sub-Fund's net assets,
- non-financial issuers: maximum 60% of the Sub-Fund's net assets (industrials or utility).

The investments of the Sub-Fund will comply with the following overall rating requirements:

- aggregate BBB exposure (BBB- to BBB+),
- maximum 35% of the Sub-Fund's net assets and overall Sub-Fund,
- rating A- or higher unrated securities,
- maximum 10% of the Sub-Fund's net assets.

The Sub-Fund will limit its investments in securities and instruments that are economically tied to emerging market countries (excluding China but including Russia, in the latter case subject to the sanctions being lifted) to 20% of its net assets. The Sub-Fund will invest no more than 10% of its net assets in shares or units of other UCITS or other UCIs. The Sub-Fund's exposure to contingent convertible bonds ("Cocos") is limited to 10% of its net assets. The Sub-Fund may invest without limitation in instruments eligible under the investment policy denominated in currencies other than the reference currency (EUR). For more information, please refer to the prospectus.

Derivatives: The Sub-Fund may use derivatives for investment purposes and for the purposes of efficient portfolio management.

Securities Financing Transactions: The Sub-Fund will not enter into transactions under SFTR.

Techniques and Instruments: The Sub-Fund will not use Efficient Portfolio Management techniques.

Benchmark and use: The Sub-Fund does not use any index under the Benchmark Regulation.

SFDR classification: The Sub-Fund qualifies as a financial product under Art. 6 of SFDR.

Distribution policy: This is a distributing share class.

Subscription and Redemption: Shares are issued on each Valuation Day at the issue price. Shareholders are entitled to request the redemption of their Shares at any time at the Net Asset Value per share.

Currency: The reference currency of the Sub-Fund is the EUR. This is a currency hedged share class and seeks to hedge the NAV, expressed in the Sub-Fund's base currency, to the currency of the share class. It is important to note that the hedge is not perfect, especially during times of market volatility. Mainly due to interest rate differentials and costs associated with performing the hedging activity the currency hedged share may have a somewhat different performance to the equivalent share class in the base currency.

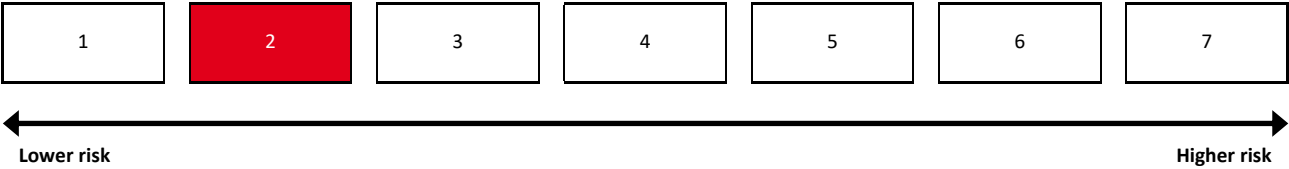

Assets and liabilities of each Sub-Fund of onemarkets Fund SICAV are segregated, meaning that your investment in this Sub-Fund is only impacted by profits and losses in this Sub-Fund. Intended Retail Investor

This share class is open for retail investors. An investment in this Sub-Fund is suitable only for investors who are able to appraise the risks and economic value of the investment. The investor must be prepared to accept a low volatility of the Sub-Fund and potentially capital losses in order to achieve returns slightly higher than the usual market's interest level. The Sub-Fund is intended for investors with a short-term investment horizon.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 2 years. The actual risk can vary significantly if you cash in at an early stage and you might get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. The risk is not considered in the indicator shown above.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment using a suitable benchmark between August 2016 and August 2018.

Favourable scenario: This type of scenario occurred for an investment using a suitable benchmark between October 2023 and October 2025.

What happens if Structured Invest S.A. is unable to pay out?

The assets of the Sub-Fund are held in safekeeping by its depositary, CACEIS Bank, Luxembourg Branch (the “Depositary”). In the event of the insolvency of the management company, the Sub-Fund’s assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary’s insolvency, or someone acting on its behalf, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations). The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

What are the costs?

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time. There is no arranged compensation or guarantee scheme for investors in the Sub-Fund.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 2 years

The recommended holding period is based on our assessment of the risk and reward characteristics and costs of the product. You may receive less than expected if you cash in earlier than the RHP since the Fund will be less likely to achieve its objectives.
