What is this product?

Type

This is a Sub-Fund (the "Sub-Fund") of onemarkets Fund. onemarkets Fund is an investment company with variable share capital (SICAV) with multiple Sub-Funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.

Term

The Sub-Fund is established for an unlimited duration. The Management Company can proceed unilaterally to a redemption of a share class of an investor or switch the holding to another share class if the investor no longer meets the qualifying criteria to maintain the share class he holds. The Board of Directors may decide under certain circumstances to compulsorily redeem all shares of the relevant Sub-Fund or share class at the Net Asset Value per share for the valuation date in respect of which such decision shall be effective, and to terminate and liquidate such Sub-Fund or share class.

Objectives

Investment Objective: The Sub-Fund aims to achieve long-term capital growth from a portfolio primarily made up of equity securities issued by companies in Europe.

Investment Strategy: The Sub-Fund is actively managed. It seeks to invest in companies where management teams are closely aligned to shareholders through ownership of business. It includes family companies, but also companies where entrepreneurs or consortiums have bought into the business. The Sub-Fund's benchmark is the MSCI Europe ex UK Index (the "Index"). The majority of the Sub-Fund's equity securities may not necessarily be components of or have weightings derived from the Index. The Investment Manager has a wide range of discretion relative to the Index.

Investment Policy: The Sub-Fund primarily invests in equity securities. The Sub-Fund will invest at least 70% of its assets in equities of European companies. A minimum of 50% of the Sub-Fund's net assets will be invested in securities deemed to maintain sustainable characteristics, defined by reference to measurements such as Environmental, Social and Governance (ESG) ratings provided by external agencies or Fidelity Sustainability Ratings. The Sub-Fund will exclude companies involved in the production and/or distribution of cluster munitions and landmines and issuers which the Investment Manager considers having failed to conduct their business in accordance with accepted international norms. No more than 20% of its net assets will be invested in emerging markets in Europe and will have no exposure in Chinese securities. The Sub-Fund will invest no more than 10% of its net assets in shares or units of other UCITS or other UCIs eligible under article 41(1)e) of the 2010 law. The Sub-Fund may invest without limitation in instruments

eligible under the 2010 Law denominated in currencies other than the reference currency (EUR). The Sub-Fund will have an exposure via ADRs/GDRs and/or closed-ended REITs up to 10% of its net assets. In addition, the sub-fund may also invest up to 20% on an ancillary basis. For more information, please refer to the prospectus.

Derivatives: The Sub-Fund will use derivatives, such as index futures, contracts for difference and FX forwards, for efficient portfolio management and hedging purposes only.

Securities Financing Transactions: The Sub-Fund may enter into transactions under SFTR.

Techniques and Instruments: The Sub-Fund may use Efficient Portfolio Management techniques.

Benchmark and use: The Sub-Fund does not use any index under the Benchmark Regulation.

SFDR classification: The Sub-Fund qualifies as a financial product under Art. 8 of SFDR.

Distribution policy: This is an accumulating share class.

Subscription and Redemption: Shares are issued on each Valuation Day at the issue price. Shareholders are entitled to request the redemption of their Shares at any time at the Net Asset Value per share.

Currency: The reference currency of the Sub-Fund is the EUR.

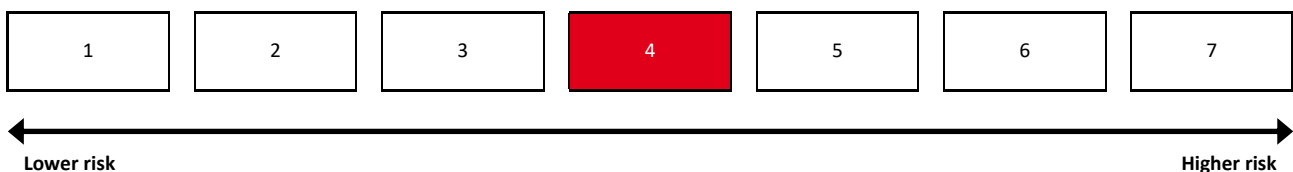

Intended Retail Investor

This share class is open for financial intermediaries which do not accept and retain inducements including intermediaries providing discretionary portfolio management. An investment in this Sub-Fund is suitable only for investors who are able to appraise the risks and economic value of the investment. The investor must be prepared to accept an increased volatility of the Sub-Fund and potentially high capital losses in order to achieve above-average potential investment performances. The Sub-Fund is intended for investors with a medium to long-term investment horizon.

What are the risks and what could I get in return?

Risk Indicator





The risk indicator assumes you keep the product for 4 years. The actual risk can vary significantly if you cash in at an early stage and you might get back less.

We have classified this Product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity to pay you.

Performance Scenarios

What happens if Structured Invest S.A. is unable to pay out?

The assets of the Sub-Fund are held in safekeeping by its depositary, CACEIS Bank, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the management company, the Sub-Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations). The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

What are the costs?

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time. There is no arranged compensation or guarantee scheme for investors in the Sub-Fund.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 4 years

The recommended holding period is based on our assessment of the risk and reward characteristics and costs of the product. You may receive less than expected if you cash in earlier than the RHP since the Fund will be less likely to achieve its objectives.
