What is this product?

Type

This is a Sub-Fund (the "Sub-Fund") of onemarkets Fund. onemarkets Fund is an investment company with variable share capital (SICAV) with multiple Sub-Funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.

Term

The Sub-Fund is established for an unlimited duration. The Management Company can proceed unilaterally to a redemption of a share class of an investor or switch the holding to another share class if the investor no longer meets the qualifying criteria to maintain the share class he holds. The Board of Directors may decide under certain circumstances to compulsorily redeem all shares of the relevant Sub-Fund or share class at the Net Asset Value per share for the valuation date in respect of which such decision shall be effective, and to terminate and liquidate such Sub-Fund or share class.

Objectives

Investment Objective: The Sub-Fund's investment objective is to seek long-term growth of capital.

Investment Strategy: The Sub-Fund will invest in Global Innovation & Transition Companies believed to demonstrate strong links to these innovations and transitions, which create societal, economic, medical, and technological changes. Strong links are defined as having a more than 10% gross revenue exposure to the themes outlined above, or spending over 10% of their capital budget to participate in the innovation & transition themes, including research & development expenditures. Under normal circumstances, the Sub-Fund will invest in approximately 50-70 companies, which may be domiciled in any country, including in emerging markets (as further specified below), and may operate in any industry or sector.

Investment Policy: The Sub-Fund invests primarily in equity securities of companies that have been identified as having exposure to the potential growth related to global innovation. The Sub-Fund invests in long-term global innovation and transitional themes that are exposed to technological innovation, health and wellness, demographic shifts and decarbonization driven by long-term secular trends. The Sub-Fund will use the MSCI All Country World Index as the reference benchmark. The Sub-Fund is actively managed with reference to and seeks to outperform (after applicable fees) the Index over the recommended holding period. The Investment Manager has broad discretion with respect to individual equity selection. The Sub-Fund is mainly exposed to the issuers of the Index, however, the management of the Sub-Fund is discretionary, and the Sub-Fund may invest in issuers not included in the Index. No more than 10% of the net assets of the Sub-Fund will be invested in shares or units of other UCITS or other UCIs eligible under article 41(1)e) of the 2010 law. The Sub-Fund will invest no more than 30% in preferred equities, closed-ended REITS and depository receipts such as American

Depository Receipt and Global Depository receipt. It will also invest up to 30% of its total assets in emerging markets companies, and up to 20% on an ancillary basis. For liquidity management purposes, the Sub-Fund may invest up to 20% of its net assets and in addition to the liquid assets referred to above, in cash equivalents. Furthermore, a minimum of 50% of the Sub-Fund's securities and instruments will be used to meet the promoted environmental or social characteristics. Derivatives: The Sub-Fund may use financial derivative for hedging purposes.

Securities Financing Transactions: The Sub-Fund may not enter into transactions under SFTR.

Techniques and Instruments: The Sub-Fund will not use Efficient Portfolio Management techniques.

Benchmark and use: The Sub-Fund does not use any index under the Benchmark Regulation.

SFDR classification: The Sub-Fund qualifies as a financial product under Art. 8 of SFDR.

Distribution policy: This is an accumulating share class.

Subscription and Redemption: Shares are issued on each Valuation Day at the issue price. Shareholders are entitled to request the redemption of their Shares at any time at the Net Asset Value per share.

Currency: The reference currency of the Sub-Fund is the EUR. This is a currency hedged share class and seeks to hedge the NAV, expressed in the Sub-Fund's base currency, to the currency of the share class. It is important to note that the hedge is not perfect, especially during times of market volatility. Mainly due to interest rate differentials and costs associated with performing the hedging activity the currency hedged share may have a somewhat different performance to the equivalent share class in the base currency.

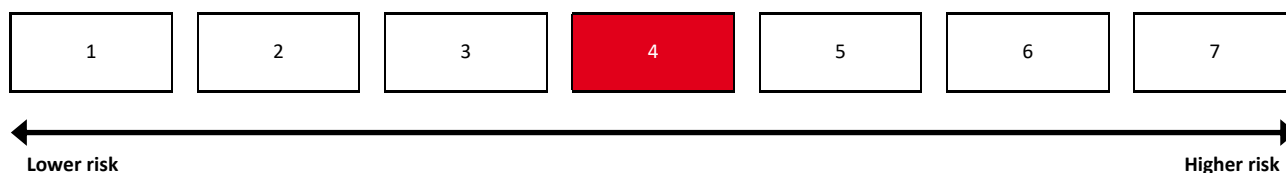

Intended Retail Investor

This share class is open for retail investors. An investment in this Sub-Fund is suitable only for investors who are able to appraise the risks and economic value of the investment. The investor must be prepared to accept a significant volatility of the Sub-Fund and potentially high capital losses in order to achieve high potential investment performances. The Sub-Fund is intended for investors with a long-term investment horizon.

What are the risks and what could I get in return?

Risk Indicator





The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you might get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. The risk is not considered in the indicator shown above.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

What happens if Structured Invest S.A. is unable to pay out?

The assets of the Sub-Fund are held in safekeeping by its depositary, CACEIS Bank, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the management company, the Sub-Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations). The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

What are the costs?

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time. There is no arranged compensation or guarantee scheme for investors in the Sub-Fund.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

The recommended holding period is based on our assessment of the risk and reward characteristics and costs of the product. You may receive less than expected if you cash in earlier than the RHP since the Fund will be less likely to achieve its objectives.
