What is this product?

Type

This is a Sub-Fund (the "Sub-Fund") of onemarkets Fund. onemarkets Fund is an investment company with variable share capital (SICAV) with multiple Sub-Funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.

Term

The Sub-Fund is established for an unlimited duration. The Management Company can proceed unilaterally to a redemption of a share class of an investor or switch the holding to another share class if the investor no longer meets the qualifying criteria to maintain the share class he holds. The Board of Directors may decide under certain circumstances to compulsorily redeem all shares of the relevant Sub-Fund or share class at the Net Asset Value per share for the valuation date in respect of which such decision shall be effective, and to terminate and liquidate such Sub-Fund or share class.

Objectives

Investment Objective: The Sub-Fund's investment objective is to provide long-term capital growth by investing primarily in US companies with positive E/S characteristics or US companies that demonstrate improving E/S characteristics. Companies with positive E/S characteristics are those that the Investment Manager believes to have effective governance and superior management of environmental and social issues ("Sustainable Characteristics").

Investment Strategy: The investment approach uses a fundamental, bottom-up equity selection process, built on leveraging the insights of a team of US sector specialist analysts that seeks to identify attractive sustainable long-term investments. The investment process integrates ESG aspects to identify companies with strong or improving Sustainability Characteristics. The Sub-Fund is actively managed. Though the majority of its holdings are likely to be components of the benchmark, the Investment Manager has broad discretion to deviate materially from its securities, weightings and risk characteristics. The degree to which the Sub-Fund may resemble the composition and risk characteristics of the benchmark will vary over time and its performance may be meaningfully different.

Investment Policy: The fund invests at least 67% of its assets in equities of companies that are part of the benchmark (MSCI USA Index) and have positive E/S characteristics, or in companies that have improved E/S characteristics. Fundamental analysis is used to better understand sustainability risks and opportunities that may impact a company. Through its inclusion criteria, which are based on Principal Adviser Impact Indicators (PAIs), the Sub-Fund promotes environmental characteristics, which may include effective management of toxic emissions and waste, as well as a good environmental record. No benchmark has been set for the achievement of the environmental or social characteristics. The Sub-Fund will invest at least 40% of assets in Sustainable Investments, as defined under SFDR, contributing to environmental or social objectives. The Sub-Fund systematically includes ESG criteria in investment analysis and investment decisions

on at least 90% of securities purchased (excluding cash). The Sub-Fund excludes the bottom 20% of securities from its investable universe based on its ESG criteria. The Sub-Fund may invest without restriction in instruments denominated in currencies other than the reference currency (EUR). The Sub-Fund will invest no more than 10% of its net assets in shares or units of other UCITS or other UCIs eligible under article 41(1)e) of the 2010 Law. In case of investments in unites of UCITS or UCITS exchange traded funds (ETFs), potential retrocession will apply. The Sub-Fund may invest up to 10% of its net assets in closed-ended REITs as well as up to 10% of its net assets in depository receipts. The Sub-Fund will, under no circumstances, use outside capital as leverage for investment purposes. It may also invest up to 20% on an ancillary basis, in order to cover current or exceptional payments or for the time necessary to reinvest in eligible assets under the 2010 law. The Sub-Fund may also invest in cash equivalents meaning: time deposits, certificates of deposits. For more information, please refer to the prospectus.

Derivatives: The Sub-Fund may not use financial derivatives.

Securities Financing Transactions: The Sub-Fund will not enter into transactions under SFTR.

Techniques and Instruments: The Sub-Fund will not use Efficient Portfolio Management Techniques. For more information, please refer to the prospectus.

Benchmark and use: The Sub-Fund is using the MSCI USA Index under the Benchmark Regulation.

SFDR classification: The Sub-Fund qualifies as a financial product under Art. 8 of SFDR.

Distribution policy: This is an accumulating share class.

Subscription and Redemption: Shares are issued on each Valuation Day at the issue price. Shareholders are entitled to request the redemption of their Shares at any time at the Net Asset Value per share.

Currency: The reference currency of the Sub-Fund is the EUR.

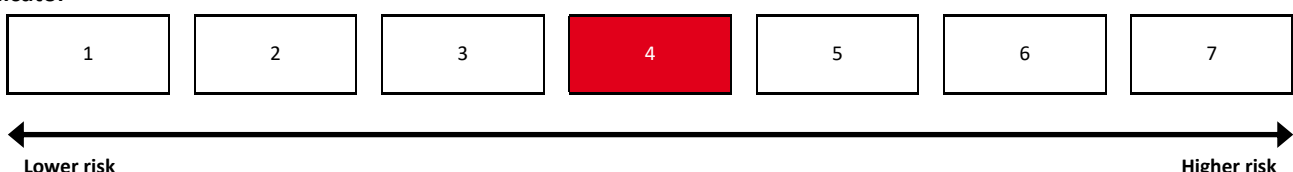

Intended Retail Investor

This share class is open for retail investors. An investment in this Sub-Fund is suitable only for investors who are able to appraise the risks and economic value of the investment. The investor must be prepared to accept a significant volatility of the Sub-Fund and potentially high capital losses in order to achieve high potential investment performances. The Sub-Fund is intended for investors with a long-term investment horizon.

What are the risks and what could I get in return?

Risk Indicator





The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you might get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. The risk is not considered in the indicator shown above.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

What happens if Structured Invest S.A. is unable to pay out?

The assets of the Sub-Fund are held in safekeeping by its depositary, CACEIS Bank, Luxembourg Branch (the "Depositary"). In the event of the insolvency of the management company, the Sub-Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations). The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

What are the costs?

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time. There is no arranged compensation or guarantee scheme for investors in the Sub-Fund.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

- HUF 5 000 000 is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

The recommended holding period is based on our assessment of the risk and reward characteristics and costs of the product.
